

## Community Health, Social Service & Education Grants Program FAQs September 2022

### **Q. What is the New Jersey Health Foundation Community Health, Social Service & Education Grants Program?**

**A.** The NJHF Community Health, Social Service & Education Grants Program awards grants up to \$25,000 each for projects to faculty and personnel at NJHF-affiliated organizations to help awardees address a variety of vital needs including health and wellness, human services, education, community development and social service issues. Types of programs include but are not limited to those that promote and improve areas such as health outcomes, crisis intervention, the functioning of special needs populations, the strengthening of family units, public safety, community centers, or any issues impacting society.

### **Q. Why was this Grant Program implemented by New Jersey Health Foundation?**

**A.** New Jersey Health Foundation's Research Grant Program is entering its 31<sup>st</sup> year. This grant program has provided, and continues to provide, researchers with important funding for early-stage research.

However, over time we have seen an unmet need for grants to support projects focused on community health and social service issues. We decided to expand the outreach of the program to include a segment of funding for health-related projects that do not fit into the criteria of the traditional Research Grant Program.

### **Q. Who can apply for funding?**

**A.** Full-time faculty members, staff and other personnel from these academic institutions are eligible to apply for funding: Cooper University Health Care, Hackensack Meridian *Health*, Kessler Foundation, New Jersey Institute of Technology, Princeton University, Rowan University, Rutgers University, Stevens Institute of Technology and University Hospital.

**Q. Does my organization need to know that I am applying for a Community Health, Social Service & Education Grant?**

**A. Yes, you must follow all of your organization's standard procedures prior to submitting an application for a Grant from an outside organization.**

**Q. What is the process for the Community Health, Social Service & Education Grants?**

**A. Applications should be submitted electronically through our grant submission portal. The link to the portal can be found on the New Jersey Health Foundation web site ([www.njhealthfoundation.org](http://www.njhealthfoundation.org)). Applications will be reviewed and scored by a New Jersey Health Foundation review panel composed of NJHF Board members and qualified members of the medical, pharmaceutical and business communities. All applicants will be notified of the status of their applications by e-mail.**

**Q. What material is required to apply?**

**A. To apply for a grant, you need to provide these documents:**

- A one-page executive summary
- A proposal limited to four (4) pages
- A CV/Bio Sketch for the PI
- A letter verifying organizational support of the application
- Literature citations (optional)
- A budget

The proposal should include:

- A. Clearly presented hypothesis and goals
- B. Background
- C. Project design & methods
- D. Description of the resources and facilities available to carry out the proposed project
- E. Evaluation methodology, including statistical approach if appropriate
- F. Possible outcomes and implications for future projects
- G. Previous or existing funding for this project

**Q. For the requested Curricula Vitae, is the NIH 5-page format acceptable?**

**A. Yes, you can upload an NIH 5-page CV or Bio Sketch.**

**Q. If there is a Co-PI on my application, do we both need to submit a CV/Bio Sketch?**

**A. CV/Bio Sketch only needs to be submitted for PI submitting the application.**

**Q. Is there a specific format for the executive summary and proposal?**

**A.** Yes, each document should be **double spaced**, in no less than 12-point type, using 1" margins. *Applications not in compliance with these guidelines will be disqualified.*

**Q. Can I request an extension for submitting a grant?**

**A.** Unfortunately, we cannot accept applications after the posted application closing date. If the deadline is missed, you may submit your application in the next award cycle.

**Q. If my proposal is not funded, can I reapply?**

**A.** The same proposal may not be resubmitted but a non-funded proposal that has been modified (due to new data, etc.) may be resubmitted in the next application cycle or any future cycle.

**Q. What information should be included in the final narrative report?**

**A.** The final narrative report should include details of the activities, conclusions drawn, estimation of the degree to which project goals were achieved, and detail on any additional funding or publications that has been secured as a result of this grant.

**Q. What is the deadline for submitting my application?**

**A.** Applications will be accepted in the portal until November 7, 2022 at 11:59 pm.
